- a) Personnel Committee

- d) Academic Committee

 - Trustee Riddle made a motion to approve the following positions: Mitchell HS, Social Sciences Instructor, Applied Engineering Faculty, Rapid Prototype Coordinator, Admin-Yancey, Admin-Avery. Trustee Norris seconded the motion, motion carried unanimously.

President's Report

Dr. Boyd presented the President's Report.

- a) Observatory Update- The Foundation approved two campaigns for the upcoming year at their recent Foundation Board Retreat. The first campaign will be for the Planetarium that will be located at the Earth to Sky Park. The project is estimated to be \$400K. The second Foundation campaign will be for an art gallery at Pinebridge. This project is estimated to cost \$400K.
 - -The Earth to Sky Park is looking to expand, adding Micropropogation, Hydroponics, a conference area, classroom, art space, picnic area, gardens, and welcome center. The septic system will need to be expanded to accommodate this project. MCC is currently applying for a grant to help fund a solar hot water system.
- b) Construction Update- The Yancey roof will be completed this week.
 - -The Crafts and Construction Trades Building is in progress.
 - -The Science Lab demolition is complete.
 - -The renovation for the new EWD/Basic Skills area is in progress.
 - -Mitchell County received \$18K in sales tax funds that will be given to Mayland to be used for renovations at the Early College.
 - -The RFQ for the Welding building will go out this week.
- c) Legislative Update- The budget is still in progress. Dr. Boyd continues to work with Representative Presnell on discontinuing the UL Inspection requirement.
- d) Hazard Mitigation MOU- Mr. Tim Greene informed the Board that a resolution was needed to be able to receive FEMA funds in the event of a hazard occurance.
 - Trustee Riddle made a motion to approve the Hazard Mitigation MOU with a second from Trustee Norris. All approved. Motion passed.
- e) The Wall That Heals- Trustee Riddle explained that the Wall That Heals will be set up at Mountain Heritage High School field for four days. The wall is replica of the wall in Washington. Mayland Community College has been involved in the funding and in bringing the wall to the area. Trustee Riddle encouraged everyone to visit the wall during the time it is at Mt. Heritage.
- f) Founder's Day 2017- Founder's Day is scheduled for July 19, 17. The Distinguished Citizen and Distinguished Alumni form has been included in the packets for Trustees to nominate award recipients from each county. Nomination forms are to be returned to Brooke Burleson.
- g) Other- The Foundation's annual fun is currently at \$241,370. The goal for last year was \$110K. \$110K is the goal for the upcoming year.

New Business

- -Mr. Ryan Ray gave the Board an update on the performance summary. The following areas are performing above the baseline level: Basic Skills, English, and First Year Progression. The following areas are performing above average: Math, Curriculum Completion, Licensure Passing Rate, and Transfer Performance.
- -The Board expressed very encouraging thoughts on the nursing graduates that most already have a job in the healthcare field or are going on to pursue their BSN.
